JOB SUMMARY:

Provide education and employment services to people experiencing homelessness and youth at-risk of experiencing homelessness to assist them in developing career plans and attaining and maintaining employment.

ESSENTIAL FUNCTIONS:

- 1) Provide direct daily education and employment services to clients, ages 15 to 24 years;
- 2) Conduct interviews and counsel clients individually or as a group;
- 3) Work with clients to develop their individualized education and employment case plan;
- 4) Assign, administer and review all elements of the education and employment plan, including Lifeline, COPS Assessments, Occupation Research, Career Planning, Resume Writing, Interview Techniques, etc.;
- 5) Help ensure all aspects of client's education and employment plan are followed and provide feedback as required;
- 6) Assist clients in dealing effectively with personal and interpersonal issues as they arise;
- 7) Supervise and/or facilitate client groups and other activities;
- 8) Develop relationships with employers to create opportunities for employment and internships for clients;
- 9) Develop education programming specific to job readiness and preparation;
- 10) Assist staff and management in the assigning and coordination of duties and tasks for volunteer pool;
- 11) Prepare month end reports and other light administrative duties as well as the creation of education and employment development aids;
- 12) Participate in staff meetings, team meetings, and other meetings as needed;
- 13) Plan, arrange, and oversee trips to education and job fairs, and other field trips;
- 14) Assist with special projects for Children, Youth, and Family Services staff;
- 15) Other duties as assigned.

JOB QUALIFICATIONS AND EXPERIENCE:

- 1) Experience working with the LGBT community and familiarity with issues of particular relevance to LGBT people;
- 2) A passion for the Center's work and its mission to make the world a better place for LGBT people;
- 3) A minimum of 2 years of experience in social service with youth or related setting required;
- 4) A minimum of 1 year of experience in an educator or employment services environment;
- 5) Excellent computer skills including word processing, database operations, spreadsheets, and other software systems;
- 6) Ability to coordinate and/or oversee the successful completion of projects;
- 7) Experience working with people experiencing homelessness and youth at risk of experiencing homelessness;
- 8) Knowledge and understanding of the issues affecting LGBT youth, including experience working with high risk youth (specific work with gay, lesbian, bisexual, transgender and/or runaway youth a plus);
- 9) Bilingual, a plus (Spanish/English preferred);
- 10) Current CPR Certificate;
- 11) Access to reliable transportation and the ability to be insured;
- 12) Good verbal and written communication skills, including strong organizational, detail, and interpersonal skills;
- 13) Demonstrated ability to work effectively with people of diverse races, ethnicities, nationalities, sexual orientations, gender identities, socio-economic backgrounds, religions, ages, English-speaking abilities, immigration statuses, and physical abilities in a multicultural environment.
